



Facilitating Tier 2 Supports: From Adoption to Implementation

- **PENT Cadre Role:** support the dissemination of resources, materials, information related to best practice in positive behavior supports.
 - Share with SELPA director (mandatory!)
 - Start the conversation with administrators or site team (and/or...)
 - Share with your job alike colleagues (and/or...)
 - Implement strategies yourself
